

Wheras in the JUDGEMENT on the appeal petition filed by SP Valliappan before the Madurai Bench of Madras High Court Dated 30 07 2009, A.S.NO.459 of 2000 and M.P.(MD) no 1 of 2009 ,respondents being SP Annamalai, A.Subraminiam, V.Subramaniam and Sethukarasi , the Hon'ble Madurai Bench of Madras High Court ordered that

15. However, as rightly contended by the learned counsel for the appellant, the 4th defendant cannot act except based on the power conferred under Ex.B59.Further , she cannot exceed the powers given to a trustee under the trust deed. Therefore, it is made clear that the 4th defendant in exercise of the power under Ex.B59 cannot act on her own. The judgment and decree of the Court below is hereby confirmed in so far as declaration and consequential injunction are concerned. However, there shall be a decree for permanent injunction against the 4 th defendant restraining her from interfering with the affairs of the management of the trustee except in accordance with Ex.B59 and also in her individual capacity. Accordingly the appeal is allowed

Out of the above said four trustees Mr. SP Annamalai has already expired on 01.09.2009 Hence the verdict rendered by the the Hon'ble Madurai Bench of Madras High Court against the suit filed by Sri. SP. Valliappan has now become redundant since the principal of the Power of Attorney holder namely Late Sri. SP. Annmalai had expired on 01.09.2009 and Mrs. Sethukarasi wife of Sri.SP Annamalai cannot enter/involve after here either in any activities of the schools run by the Trust or in the trust activities, namely Subramanim Chettiar and Kamalam Achi Educational and Charitable trust.

Hence after taking into consideration the above point the present Board of Trustees of the Board is on this date has as follows.

- 1.SP. Valliappan, S/o. Subramaniam Chettiar, No:8, Selvam Nagar, Thanjavur.
- 2.V.Subramaniam S/o. SP. Valliappan, No:374-P3, Selvam Nagar, Thanjavur.
- 3. A.Subramanian S/o. Late SP. Annamalai, No:1, State Bank colony, Medical College Road, Thanjavur.

Whereas the Board of Trustees of the said Trust resolved special resolution in their Board Meetings held on various dates, to admit four trustees in the Board in the hitherto unfilled four vacancies as per the provisions made in the objective No 4, Page 3, of the original deed of which one vacancy arose on the demise of Mr.Sp. Annamalai, for the purpose of best administration of trust.

Whereas for the best administration of the trust the following two clauses are added in addition to the conditions/objectives of the original trust deed dated 07 09 1988, namely

- 1. Any person shall cease to be a Trustee either
- (i) if he/she without information does not attend three consecutive meetings of the Trustees or for one calendar year whichever is longer or (ii) if he/she is requested to resign by 2/3th or as near thereto as possible of the remaining trustees.

Whereas Mr.SP. Valliappan, son of Sri A Subramaniam Chettiar, Founder and erstwhile trustee of the Trust, shall herein after be called as Managing Trustee, and Mr.V.Subramaniam son of Mr. SP. Valliappan shall herein after be called as Executive Trustee and the Board of Trustees of the said trust unanimously authorized the Managing Trustee Sri SP.Valliappan to execute the Second Amendment deed of Subramaniam Chettiar and Kamalam Achi Educational and Charitable Trust and register the same with Sub Registrar of Thanjavur, by resolution passed in their Board Meeting held on 23 February 2017.
